By signing this release of liability and using the pool, I agree to indemnify and save harmless Fort Bliss MWR and their employees, elected and appointed officials, and agents from any and all liability from claims of bodily injury, property damage, or any other nature whatsoever arising out of the use of Fort Bliss MWR's properties herein specified.

DAY RULES

- ONLY WELL-MANNERED DOGS AND THEIR WELL-MANNERED HANDLERS ARE ALLOWED TO PARTICIPATE
- DOGS EXHIBITING AGGRESSIVE BEHAVIOR WILL BE ASKED TO LEAVE AND WILL NOT BE GIVEN A REFUND
- PROOF OF CURRENT VACCINATIONS, RABIES, PARVO/DISTEMPER FROM YOUR VET ARE REQUIRED. A RABIES TAG ALONE WILL NOT BE ACCEPTED
- EACH DOG MUST BE ACCOMPANIED BY A RESPONSIBLE DOD ID CARD HOLDER 18 AND ABOVE
- NO DOGS IN HEAT OR UNDER FOUR MONTHS OLD ARE ALLOWED
- NO UN-FIXED DOGS ALLOWED
(YOUR PET(S) MUST BE NEUTERED OR SPAYED)
- CLEAN UP AFTER YOUR DOG, THERE IS A DESIGNATED BATHROOM AREA, POOP BAGS WILL BE PROVIDED
- FEEL FREE TO BRING YOUR OWN DRINKING WATER, COMMUNITY WATER WILL BE AVAILABLE
- NO GLASS CONTAINERS ALLOWED
- DOGS MUST REMAIN LEASHED UNTIL THEY REACH THE POOL AREA
- ANYONE ENTERING THE POOL AREA IS REQUIRED TO SIGN A RELEASE OF LIABILITY FORM
- IF YOU ARE GOING TO ENTER THE POOL WITH YOUR DOG YOU MUST WEAR PROPER SWIMMING ATTIRE
- CHILDREN FIVE AND UNDER ARE NOT ALLOWED AT THE EVENT
- CHILDREN BETWEEN THE AGES OF 6-18 ARE NOT ALLOWED INSIDE THE POOL
- THERE IS A 2 DOG PER ADULT DOD ID CARD HOLDER 18 AND ABOVE MAX
- DOGS MUST WEAR A COLLAR WITH ID TAGS
- DOGS MUST REMAIN UNDER THE HANDLERS CONTROL AT ALL TIME
