
What it is...

- The federal government includes all branches of the federal government system, such as the departments of: Treasury, Interior, Defense, etc.
 Military organizations include officers' clubs, enlisted men's clubs, NCO clubs, billeting funds, etc. All federal government/military agencies are direct employees of the federal government.

What it is not...

 You are not considered a federal government or military organization if you are a contractor doing business with the federal government or military.

If you need to change your type of structure, we recommend that you do so **now**, otherwise you will have to start over and re-enter your information. Additional help may be found by reviewing <u>all types of</u> organizations and structures before making your selection.



Yes the Treasurer will need to input their SSN number. The IRS requires this so they have a contact person regarding this organization and so the individual responsible is protected from tax liabilities for the money raised by the FRG.



Step 11:

When filling out this form provide the Unit's Address and the Unit's number. The name for the EIN number should always be the Unit. The example above is for Delta Company 123rd BSB. The mail should always be address to the Treasurer of the FRG. All Mail must go to the unit's address. **DO NOT PUT THE TREASURER HOME ADDRESS IN THIS**
