WHAT:	Fort Bliss – Commander's Cup Softball
<u>WHEN:</u>	Coaches Meeting: 27 March 2024 / Soldier Activity Center / 1800 Officials Clinic: 8-11 April 2024 / Aquatic Training Center / 1800 Regular Season: 15 April 2024 – 13 June 2024 Post Championship: 10 June 2024 – 13 June 2024
WHERE:	Omar Bradley Complex, 2968 Carter Rd.
LEAGUE STRUCTURE:	Unit (Company/Battery) teams will be divided equally between the Eastern & Western Conferences for league play, depending on which major command (MSC) their unit falls under. The regular season is eight weeks, followed by a one-week post championship tournament. Games will be played MON-THUR starting at 1800.
<u>ELIGIBLITY:</u>	Active-duty military personnel, Army Reserve, and National Guard service members in an active status assigned or attached to Fort Bliss.
	Team rosters will be limited to 15 players, and one non-playing coach. Rosters must be submitted prior to the first scheduled game. Rosters must be in memo form with members first and last name and a contact phone number of the coach or team representative. Rosters must be signed by Commander or First Sergeant of the battery/company/troop.
	BDE/BATTALLION teams are not acceptable and will result in a forfeit . Soldiers must play for their company, and in the instance their company does not have a team, they must contact their sports coordinator in order to be placed on a team. If placed on another team, their Commander or First Sergeant must sign a memorandum releasing them to play for another company. The receiving company Commander or First Sergeant must sign a memorandum acknowledging that they accept the player onto

		ir company team. To be eligible for Post Tournament play, no re than two non-company players can be placed on a team.
	tea	yers cannot play with multiple teams. Once they play for a m, they cannot change teams. This will result in a forfeit for second team.
	Lacl	itary IDs will be checked against the roster prior to games. k of military ID will result in the player not being eligible to play t game.
LEAGUE PLAY:		y will be conducted in accordance with the 2023/2024 USSSA es unless otherwise covered by these by-laws:
		The duration of the game will be 55 minutes, with the inning in progress to be completed.
		Each batter will assume a one ball and one strike count and will be allowed one courtesy foul ball after two strikes.
		 If the score is tied at the end of seven innings or 55 minutes, a tie-breaker rule will be put into effect as follows: (1) The visiting team will place the last batter of the previous inning on second base and the game will continue from that point with the same batting order until three outs are made, and the inning is completed. (2) The home team will use the same procedure as described above. (3) The above procedure will be used for the remainder of the game until a winner is determined.
		A 20-run rule will be in effect after three innings, 15-run rule will be in effect after four innings and a 10-run rule will be in effect after five innings.
		Complete innings must be played unless the home team scores the go ahead run while at bat during final inning.
		In the event of a homerun, the batter, and any runners, will not run the bases. This eliminates any appeal play.
	-	No runners will lead off the base they occupy, and no base stealing is allowed.

- h. Any player found to be using an illegal bat will be suspended for the remainder of the season.
- i. A team can start the game with a minimum of 9 players.
- j. The lineup or batting order can have up to 11 hitters and must finish the game with 11.
- k. The home run limitation is three.
- If a ball is batted fair or foul by the batter when either one or both feet are in contact with the ground completely outside of the batter's box, or when the foot is in contact with home plate, the batter is out.
- m. Each team will be provided with a scorebook at the beginning of the season. It is the responsibility of each team to keep the game records, with their own scorebook. The home team will keep the official book, unless they do not have enough personnel.
- n. Each team will be provided with lineup cards at the beginning of the season. It is the responsibility of each team to provide the lineups to the opposing team and to the umpire prior to the start for each game. In addition, all substitutes must be announced to the umpire and the opposing team.
- All players, coaches, bookkeepers must remain within the dugout during game play. Only exceptions are (1) the next batter on deck for the team at bat, and (2) players or coach occupying the designated coaching areas near 1st and 3rd base, for the team batting.

8. FORFEITS: The clock will start at scheduled game time. If teams are late they will assume play when the minimum requirement of players are available to participate. If the minimum required players are not available by 10-minutes after the game clock has started the game will result in a forfeit.

Forfeiture of two games during league play will result in disqualification from the league play and the Championship Tournament. All remaining league games may be considered a win for the opposing teams. are then not eligible to participate with any other teams.

EQUIPMENT:	All bats must be USSSA approved. Softballs will be provided by MWR Sports.
	Leg/arm braces must be wrapped in tape (No metal showing).
	If a cap is worn, it will be worn properly. Military uniforms/boots are not allowed.
	Sunglasses are not allowed to rest on the brim of caps while at bat or in the field of play.
	No metal cleats or screw-ins of any kind. Rubber molded cleats are acceptable.
	No jewelry is allowed. NO EXCEPTIONS
	Face masks are recommended for all pitchers.
	No bat weights/donuts allowed.
	Teams and spectators are not allowed to use electronic communication devices to communicate with players during game.
<u>PROTESTS:</u>	A protest concerning eligibility must be submitted in writing to the League Director by 1300 hours the following working day. A ruling will be decided before the team's next scheduled game.
<u>POSTPONEMENTS:</u>	Postponements will only be granted when unit duty commitments warrant. Notification must be submitted to the respective Sports Coordinator 48 hours prior to scheduled game. There is no guarantee that postponed games will be rescheduled. Inclement weather postponements will be determined by the Sports Office Representative on site.
<u>SPORTSMANSHIP:</u>	Swearing and abusive remarks: Whether directed towards opponents, team members, officials, fans or supervisors or indirect frustration about self-performance are behaviors which cast a negative atmosphere over intramural play and may lead to more serious problems. Officials may penalize such behavior and all cussing with an ejection.
	The first unsportsmanlike conduct received by a player or coach may result in an ejection from the game and a warning being filed.

The second ejection in the season will result in a meeting with the
Sports Director for a possible suspension. The third ejection will
result in an automatic ejection from the league.

Taunting will not be condoned. First occurrence – Team Warning. Second occurrence – Ejection.

A player, coach, spectator or the entire team may be asked to leave the playing area if displaying unsportsmanlike conduct. Any contest may be forfeited by the administrator or official of the activity when a team, a team participant, captain or coach exhibits unsportsmanlike conduct or disruptive behavior during the contest. Team captains or coaches may be warned prior to forfeiting the contests. However, it will be at the discretion of the administrators to forfeit that contest if deemed necessary to avoid a violent confrontation. Players/Coaches ejected for a first offense may be suspended indefinitely from participating in sports activities, depending on the severity of the offense.

Alcohol, smoking, vaping, or use of chewing tobacco is not permitted in the facility. Any player or coach under the influence of alcohol will not be permitted to enter the playing area. Smoking is only permitted at the designated smoking area and individuals smoking are responsible for properly disposing of their tobacco products.

COACH'S MEETING: A Coach's Meeting will be held on 27 March 2024 at 1800 at the Soldier Activity Center. This meeting is mandatory for all coaches or team POC. The season will begin on 15 April 2024.

PETS:Pets are prohibited from being at the Omar Bradley Sports
Complex IAW USAG 190-4 Sec. 1-10.

RESPONSIBILITIES: During league play, the manager or coach is responsible for ensuring that:

(1) All members of the team are familiar with the MOI.(2) The team is fully equipped and properly attired.

(3) No illegal players participate in games.

(5) Team roster is submitted prior to the first game.

<u>PARTICIPATION POINTS</u>: Major commands will receive 10 points for each subordinate unit team that participates in league play. Maximum 50 points awarded.
