

Eligibility:

- 1. Contestants must be Active Duty, National Guard or Reserve from any branch of Service, or a family member sixteen years or older with valid military ID card, or DoD Civilians.
- 2. Military contestants may not have any adverse actions pending. Service members whose records are flagged or with UCMJ actions may not compete.
- **3.** Contestants must be amateur status and not perform professionally. No professional entertainers performing/competing in their area of entertainment.
- **4.** Contestants must be located within the Fort Bliss area.
- **5.** Employees of Fort Bliss DFMWR Marketing/Special Events are not eligible to participate.

Here's how to compete (PERFORMANCE):

- 1. Submit a signed and dated application stating that you have read these official rules along with your video submission to blissmwr@gmail.com
- 2. All materials performed must be appropriate and conform to good standards. Lyrics, costume, and performances should be compliant with Army values, morals, and appropriate for all audiences. The appropriateness of all performances will be at the discretion of DFMWR.
- **3.** Performances should be recorded in **landscape mode**. Each performance is recommended to last no longer than three minutes.
- **4. DO NOT** use any special effects or auto tuners in your video submissions or they will be disqualified.
- 5. Contestants must be prepared to record a second performance (as in a different song or dance) if they are chosen as a weekly winner. The second performance would be due 3 business days after they are notified of winning.

Due dates for second performances:

Week 1- February 10th

Week 2- February 18th

- Week 3- February 24th
- 6. Winners will be given the option to have their second performance recorded in our studio and polished by our MWR staff. This option can be scheduled when notified of winning, but must be completed within 3 business days.

Competition Format:

- 1. THE TOP 12 SUBMISSIONS WILL BE CHOSEN BY DFMWR Marketing TO COMPETE IN A 4 WEEK COMPETITION IN THE MONTH OF FEBRUARY. A minimum of 6 submissions are needed for the competition to proceed.
- Weeks 1, 2, 3 Each Monday, four (4) contestant's submissions will be compiled into one video accessible from our FaceBook Page https://www.facebook.com/blissmwr, our FaceBook

audience will be encouraged to vote for their favorite contestant through the use of designated emojis. Voting will close at 1200 on the Friday of each week. Winners will be notified by the close of business on the Friday of their competition week.

- **3.** Finals week will be a competition between the winning contestant from week 1,2 & 3. This will consists of a second performance demonstrating the same talent. Audience votes will count for 50% of the votes in this round. The remaining 50% of votes will be cast by the event sponsor's representative judge.
- **4.** In the event of a tie votes of sponsor judges will be used to break the tie.

Prizes:

1. Monetary prizes will be awarded to first, second and third place winners in the final round only. The prize amounts are as follows.

1st place - \$500 2nd place - \$250 3rd place - \$100

2. Winners must present their DOD ID Card in order to claim their prize.

Prize acceptance:

1. DFMWR reserves the right to substitute prizes of an equal or greater than value. Winners are solely responsible for reporting and payment of any taxes on the prize.
