Fort Bliss FMWR POV Resale Lot**

**Your initials and signature indicate you acknowledge and agree to the following POV Resale Lot policies:**

\*A refund will not be issued for a POV Resale Lot Permit purchase, regardless of when the vehicle is sold.

\*Each permit is valid for one month or 30 days. The maximum length of time a patron may have their vehicle on the POV Resale Lot is 180 days (6 months).

INITIAL

\*Each military ID card holder may have no more than two (2) vehicles for sale on the POV Resale Lot each calendar year.

INITIAL

\*Permits are non-transferable between vehicles and patrons. Issued permits are valid only for the patron and vehicle listed on the POV Resale Lot registration form.

INITIAL

\*To obtain a permit valid for one full month the required documents, including vehicle registration and insurance, must also be valid for at least the full month.

\*While the vehicle remains on the POV Resale Lot, patrons are responsible for ensuring their permit is posted on/in the vehicle and is always in plain view.

INITIAL

\*A current license plate/registration sticker with an unexpired date must be in plain view on the patron's vehicle while the vehicle remains on the POV Resale Lot.

INITIAL

\*Patrons are responsible for renewing their permit by the expiration date stated on their permit, otherwise, patrons are responsible for removing the vehicle from the POV Resale Lot by 11:59 pm on the date the permit expires.

\*Patrons are responsible for returning their permit to the Leisure Travel Services office once their vehicle has been sold or removed from the POV Resale Lot.

\*Failure to comply with any of the POV Resale Lot policies or management directives may result in the loss of POV Resale Lot privileges.

\*A patron's vehicle may be towed, at the owner's expense, if the patron fails to comply with any of the POV Resale Lot policies or management directives.
