*Permits are non-transferable between vehicles and patrons. Issued permits are valid only for the patron and vehicle listed on the POV Resale Lot registration form.	INITIAL
*Each military ID card holder may have no more than two (2) vehicles for sale on the POV Resale Lot each calendar year.	INITIAL
*Each permit is valid for one month or 30 days. The maximum length of time a patron may have their vehicle on the POV Resale Lot is 180 days (6 months).	INITIAL
